

#### Face Masks

Please can we remind Parents and Carers as per our current Procedures and Protocols which all Parents have agreed too, that **face masks need to be worn when dropping off and collecting your child at both CHUF settings**. Masks need to be in place before you enter the grounds of either setting, so in Chearsley they need to be worn as soon as you leave your car (if parking in the car park) or as you enter the Village Hall grounds if walking, and in Haddenham masks need to be in place before you enter any of the school grounds. In the run up to half term we have had to remind several Parents and Carers that masks must be worn. The whole of the CHUF team are trying our level best to ensure that both settings are as safe as possible and that they remain open so please do help us by remembering to wear your mask (Please note that this applies only to adults, children are not required to wear masks).

### Haddenham Drop off Times

Please can we remind Parents and Carers that drop off time for the Haddenham CHUF morning sessions is **9.10 to 9.20 am**, and collection from the morning session/drop off for the afternoon session is at **12.10pm**. Outside of these times, gates into the school playground will be shut and locked, the main gate at the end of school drive will also be closed. So please can we ask you to ensure that where possible you arrive on time for drop off and pick up. Drop off and pick up outside of these times means that a member of staff has to leave the setting to unlock the gates, which is not ideal. In exceptional circumstances please do let us know if you are going to be late/early for pick up or drop off by calling the setting on 01844 299123, and we will ensure someone is available to open the gates for you. #### World Book Day Thursday 4th March 2021

World Book Day takes place on Thursday 4th March 2021 this year and at CHUF we will be joining in with the celebrations. Children are invited to come to **CHUF on Thursday 4th March (Or if they don't attend CHUF's on a Thursday one other day W/c 1st March**  that they do attend) wearing fancy dress, children can come dressed as their favourite character from a book (However, there is no pressure to do this and if they would rather just come to CHUF in fancy dress that's absolutely fine). Please do note though that all items being brought into the setting will need to be **clearly labelled with your child's name** as past experience shows that children often don't want to stay dressed up for the whole session. Please can we also ask that **accessories are kept to a minimum** as well so that we can still try to minimise items brought in from home and therefore stick to our Covid protocols as much as possible. We look forward to seeing your children's outfits.

### Early Years Pupil Premium (EYPP)

We are delighted to let you know that at Chearsley CHUF we have purchased the following items using Early Years Pupil Premium (EYPP) monies: a balance bike, a scooter, 2 board games and items for messy mixing. The Early Years Pupil Premium (EYPP) is additional funding for early years settings to improve the education they provide for eligible 3 and 4 year olds, and is claimed alongside funding for your child's sessions. If you think you might be eligible for this premium, please do complete the EYPP section of the next funding form you receive, and an eligibility check will be run by CHUF. EYPP amounts to an extra 0.53p per hour an eligible child attends, so can make a real difference. Your child may be entitled to pupil premium funding if you receive one of the following benefits: Income Support. Income Based Job Seekers Allowance. Child Tax Credit Only (with income up to £16,190) with no element of Working Tax Credit.

### **Tax Free Childcare Scheme**

This is a reminder that CHUF is registered to accept payments in from the Governments Tax Free Childcare scheme that was set up in April 2017. This scheme enables eligible Parents to get up to £2,000.00 per child per year towards their childcare costs (The Government will pay £2.00 for every £8.00 you pay your childcare provider). This is paid via an online childcare account that you will need to set up for your child.

Please note that we have been advised by the HMRC that although we are a duel setting provider that we are only required to be registered once under our original setting (Chearsley). Please therefore only use the details provided below and do not try to search for the Haddenham setting., as the Haddenham setting's details cannot be found on the list of childcare providers.
